## Visitor's Acknowledgment of Risks

In consideration of the services of Silver Salmon Creek Lodge, Inc., operator of Silver Salmon Creek Lodge, its officers, agents, employees and shareholders, and all other persons or entities associated with the corporation or Lodge (collectively, "**SSCL**"), I agree as follows:

Although **SSCL** has taken reasonable steps to provide me with appropriate equipment and skilled guides so I can enjoy an activity for which I may not be skilled, **SSCL** has informed me this activity is not without risk. Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of this activity. These inherent risks are some of the same elements that contribute to the unique character of the activity and can be the cause of loss or damage to my personal property, or accidental personal injury, illness, or in extreme cases permanent trauma or death. The following activities provided by **SSCL** are those which have such inherent risks:

**Brown bear viewing & photography, sport fishing along stream banks, off-shore halibut fishing, wilderness tent camping, coastal and island tours by boat, transportation in the field by ATV, sea-kayaking, and all other related services provided by SSCL.**

I am aware that if I participate in the above-related activities there is a risk of personal or property injury or death to any participant. I understand that there may be other unknown or unanticipated inherent risks, as a result of participating in the above-described activities, which may result in personal or property injury or death to a participant. I agree to assume and accept full responsibility for the inherent risks of injury to myself or my property as a result of participating in any of the above-described activities. My participation in any of these activities is purely voluntary; no one is forcing me to participate, and I elect to participate in spite of and with full knowledge of the inherent risks.

I acknowledge that engaging in any of the above-related activities may require a degree of skill and knowledge different from other activities and I have responsibilities as a participant. I acknowledge that the staff of **SSCL** has been available to more fully explain to me the nature and physical demands of these activities, and the inherent risks associated with them.

I certify that I am fully capable of participating in any of the above-described activities. Therefore, I assume and accept responsibility for myself, and any minor children in my care, custody or control, for any bodily injury, death, or damage to or loss of my (or my children's) personal property, and any expenses incurred as a result of such injury or loss, resulting from my or my children participating in any of the above-related activities, whether caused by the inherent risks associated with those activities, unknown or unanticipated inherent risks, or my negligence in participating in any of these activities.

I have carefully read, clearly understood, and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me, my heirs, assigns, personal representative and estate, or the personal representative and estate of family, including my minor children.
